




## CAVITY INSTALLATION OPTION




Build the chimney framework with consideration to flue pathways and meet the minimum fireplace opening requirements (850mm H x 1320mm W x 350mm D). Ensure a continuous base for the fireplace.



Install electrical, network connections, and gas supply. Connect flue pipes to the fireplace and create the flue pathway to the terminal. Connect Powerflue electrical cable at both ends.



Install the appliance into the preformed cavity opening and secure it to the base. Ensure the fireplace is flush with the framework. Provide mains power connection and an accessible isolation switch.



Attach wall linings to the framework and fireplace, maintaining a 5mm gap from the fireplace trim. Follow the provided wall lining cutout dimensions above. Complete the project by adding additional finishes or fixtures.

#### CAVITY OPTIONS

Please Note: the DN1150 Gas fireplace is non-load-bearing, make sure to provide sufficient support for any framework or building components above it. The DN1150 Peninsula gas fireplace is versatile for room installation in different configurations. It fits beneath counters or cabinetry with a capped framework at the minimum cavity height. The cavity can be made from various materials, both combustible and non-combustible. Extra heat protection might be necessary for recessing or joinery specifications.

NOTE: Available as an accessory, the Kitset Wall Unit (KWU) can assist in installation of the DN1150 Corner and Peninsula models. This metal support structure simplifies setup and can hold up to 500kg of framework and cladding without transferring load to the fireplace.

#### FIREPLACE BASE

Install the fireplace on a minimum 12mm firm, continuous surface like a concrete floor, plywood, or compressed cement sheet. Avoid installing directly on carpet, rugs, or heat-sensitive floor finishes.

#### **TV CLEARANCE**

When mounting a TV or electrical appliance above a fireplace, this can be completed surface-mounted or recessed. Ensure the TV's base is at least **200mm** above the glass viewing area. Note that TV clearance recommendations are suggestions only, and Escea is not responsible for their compatibility with all electrical appliances.

#### FIREPLACE AND CAVITY DIMENSIONS

Fireplace Width (A) including 14mm finish trim	1288mm
Fireplace Height (B)	795mm
Fireplace Depth (C) including 14mm finish trim	380mm
Framed Cavity Opening Width min.	1320mm
Framed Cavity Opening Height min.	850mm

#### FINISHES

Use 10mm to 20mm deep wall linings or finishes, taking care to select materials suitable for the installation. Prevent combustible or heat sensitive wall linings from extending forward or beneath the 14mm fireplace trim.


Maintain a 3mm gap (+/- 2mm) to the fireplace's finishing trim. Replace the 14mm fireplace trim with the 22mm Extended Trim Kit or a custom solution, for adequate heat protection. Prolonged heat exposure may damage the appearance or long-term performance of wall linings.

\*This detail is applicable for all sides of the fireplace viewing area.



#### Ensure all clearances are met to any combustible or heat sensitive materials in front, above, to the side, or below the fireplace viewing area. Following these clearances, will allow the use of standard building materials, whether combustible or noncombustible.

Ensure that any combustible mantels or protruding ledges above the fireplace are positioned at least 200mm above the viewing area. Mantel height depends on its depth; the greater the protrusion, the higher the clearance. 
A hearth is not necessary, but if used, a combustible hearth must be at least 100mm below the glass viewing area or made entirely of non-combustible materials.

Install in accordance with AS/NZS5601.1 and the Escea DN1150 Peninsula Install Manual. Contractors and installers should verify all dimensions on site prior to the manufacture or construction of any structure or finishes.
